Vice Chair Sieglen Perry moved to approve the minutes, seconded by Member Jackson seconded. Approved unanimously with Member Roosen absent.

INFORMATION/DISCUSSION

1. Return to in-person meetings

Liaison Curtis stated that the return in in-person meetings Citywide will begin February 9. The Board's next meeting is February 8, thus the first in-person meeting for the Board is its March 8, 2023, meeting. Ms. Curtis has secured the 4th floor of 1200 Third Avenue, San Diego, CA 92101 for the meetings, which is the same location Board meeting were prior to Covid. All members indicated they could attend in person, with a request for wearing of masks at all in person meetings.

2. Continued Discussion and Creation of the Accessibility Advisory Board 2023 Work Plan

The board began brainstorming ideas for their 2023 Work Plan in November 2022; this is a continuation of the discussion. Board staff will create a matrix for the final work plan with lead and support board members for each item.

Chair Wolford: find more activists to participate and help open a dialog with Councilmembers and Mayor's office regarding items coming to Council and Committees. Compile list of volunteer opportunities in San Diego (Member Markoski www.voluntermatch.org – nonprofits post openings and projects and people will sign up through that org).

Member Sieglen Perry – Personnel or HR to come speak about hiring people with disabilities in the City. Liaison Curtis told group she had already set up meeting with PRIDE Industries and the City's Internship Management Team in Human Resources. PRIDE Industries helps match people with disabilities with employment opportunities, and has an internship program the City could participate in.

Member Markoski – has expertise in data and can work on compiling data for City.
