- 2) CIP Update.** CIP Subcommittee will present the draft CIP Update provided by the City. GGHPC to evaluate making any final changes or re-numbering of priorities.
- 3) Recommendation to the City of San Diego Redistricting Commission –** GGHPC to consider making a recommendation(s) regarding the City's redistricting as it pertains to Greater Golden Hill.
